- Defendants described admitted errors as "honest mistakes," despite contradictory evidence
- Automated billing platform (BILT): false notices, phantom charges, improper withdrawals
- Case involves federal funds through HUD-VASH and Section 8
- Evidence includes corporate emails, bank statements, screenshots, ledger discrepancies
- Highlights systemic vulnerabilities in algorithmic billing systems used nationwide by Wall Street landlords

National Relevance

- Provides rare direct proof of misconduct by a major corporate landlord
- Exposes algorithmic billing mechanisms that affect millions of renters
- Highlights lack of oversight in HUD, PHAs, and local housing authorities

- Demonstrates how corporate landlord systems bypass safeguards for low-income tenants and veterans
- Offers a model case for journalists, policymakers, and regulators studying housing system failures
